


Astrology Patterns with Tarot.

In this lecture, I will continue to use my
Astrology chart to demonstrate how
we can learn the patterns and symbols
of Astrology with Tarot to assist with
our subconscious response for a more
accurate overview with our life destiny.

The previous lecture demonstrated how the astrology quadrant system can use symbols and patterns to isolate and determine our pre-birth 'needs' and pre-birth 'intent' from an overview perspective.







## Astrology Patterns with Tarot Part 3

We have identified and established the rulers of each quadrant on the Personality layer of my astrology chart.

The primary reason why we need to identify the quadrant rulers on the Personality layer is because we can extract the symbols from the four quadrants that will allow us to focus on how to penetrate to the Foundation layer.

We use the symbols to identify the attributions that are assigned to the Zodiac sign,
Houses, Planets, and Tarot because these are the influences that shine through our Personality and reflect inwardly, which creates the Persona that is used to navigate life and how we initially perceive our life.

Before we begin to create the twelve fragments of the four quadrants which will reveal how our subconsciousness responds to our suggestive states that are provided by our self-conscious observations, which is the primary source for navigating life, making choices, and creating personal experiences, first, we need to determine our life-line.

The life-line can pinpoint to the closet degree in our life which is the unfolding of our consciousness growth and development.

We determine the life-line with simple math, which is 3.5 multiplied by our life-age.

The reason why we multiply by 3.5 is because this equals the approximate movement in degrees per Earth year for a human life.

For example, my life-line moved through the 1st house of my astrology chart from age zero to age 6.5 years old.

On the Foundation layer, this house is ruled by Aries and is attributed to the physical development of a body, which applies to all human beings, but in order to individuate and appear separate, we incarnate at different degrees for our initial position at birth in order to rearrange our atomic structure on our chromosomal strand within our DNA molecules.

This creates the Personality layer and is what changes the characteristics of us as individuals which has to do with the distance between the atoms on our chromosomal strand. Our life-line is important to determine because we will know approximately when our planets will phase-in and become activated within us to make effort on accomplishing our pre-birth 'intents'.

Each astrological planet represents a genetic potential to accomplish something in a certain area of our lives, which is why the planets represent our 'intent' and also our future.

Each quadrant represents a different genetic potential and also represents the possible different phase in our life which these qualities will be more pronounced than in other areas or phases within our life.

With my first quadrant and ascendent Zodiac sign of Cancer, my Persona will be colored with the Cancer attributions and also Key 7 attributions of Tarot.

After I reached the age of 15 years old,
my life-line has moved through the 1st and 2nd House,
which are small in degree and reveals some of my
pre-birth 'needs' for this lifetime.

Also at the age of 15 years old, my life-line activates the first pre-birth 'intent' in my astrology chart, which is the planet Jupiter.

My 3rd house is balanced at 30 degrees, but I have pre-birth 'intents' in this house which is clue for the creating of potentialities to accomplish something in this life.

The life-line activates the Jupiter qualities within the Virgo house on the Personality layer, which means my subconsciousness will respond to what it has available to work with as I navigate life at my age of 15 years old of accumulated 15 years of life experiences.

After I reach the age of 45 years old in January 2025, my life-line will be approximately 158 degrees in the 6th house with the Zodiac sign Sagittarius.

Within this phase of life, I have activated six pre-birth 'intents' which are Jupiter, Mars, Saturn, Pluto, Uranus, and Neptune.

My astrology chart reveals a focus of strong 'intent' for subjective development of my emotional and mental bodies in order to experience potentialities that will come forth for me to accomplish my pre-birth life plan for this lifetime.

## Astrology Patterns with Tarot Part 3

- Let us remember that with our astrology chart, the House size represents our past, the Zodiac sign represents our present, and the Planets will represent our future.
- If we look at my life-line at 158 degrees, we notice the symbols of Neptune and Sagittarius in the 6th House, which is a house size of 32 degrees.
- The house size determines that I do not have pre-birth 'needs' for 6th House qualities, but I do have the pre-birth 'intent' with Neptune that has been activated in Sagittarius.
- I can know that the Sagittarian influences are strong in my now moment of age 45 years old by simply reflecting on my past and present life experiences, day-to-day choices, which involve thoughts, emotions, and actions.
- I'll speak more in detail on the 6th house attributions and how they are applied to my life in later lectures when we create the twelve fragments of the four quadrants, but for now we can view my astrology chart as an example of how the first half of my life is symbolically coming to a close because my life-line is about to enter my descendent, the 7th House and the top half of my chart.

- Once my life-line exits the 2nd quadrant and enters the 3rd quadrant, I will symbolically begin the 2nd half of my life.
- There are four Planets of objective 'intent' to become activated, which the other six Planets contributed to my subjective 'intent'.
- The remaining four Planets to be activated are in my small 3rd quadrant which reveals strong intent for social development in that particular phase of my life.
- My Sun sign is in detriment of my 7th House of Aquarius, which reveals a difficult placement, but more importantly, I know that relationships are a pre-birth 'need' and pre-birth 'intent' for this life.
- My chart reveals that the 3rd quadrant of social development and my 7th House is an area of life that I want to gain new light and new understanding for my consciousness growth.
- At the age of 65, my life-line will enter my 9th House which has assigned the Zodiac sign of Pisces along with my final two Planets of 'intent' that will be activated in order to assist with fulfilling my life destiny.

- Finally, the 4th quadrant has large Houses and zero Planets of 'intent', which indicates that career development will most likely not have a strong influence in the 2nd half of my life.
- Overall, my chart reveals that this lifetime will most likely consist primarily of inner world explorations of myself with very few relationships with others, more of quality relationships over quantity.

- In the next lecture for Astrology Patterns with Tarot, we will explore the symbols and attributions for my 1st quadrant of the Personality layer and the Foundation layer.
- I will share my experience on how the influx of energies for Cancer, Leo, and Virgo shaped my life within the environment that I was born in with my Earth family.
- When we relate our life experiences by using our life-line to the Houses, Zodiac signs, and Planets, then our subconsciousness will receive the symbols and images needed so that we can ultimately have the understanding of 'know thyself, and we can 'accept thyself for we created this life prior to our incarnation.

We chose to incarnate and experience all the emotions, all the limitations, all that human life will present in a journey as we observe ourselves from our thoughts, our words, and our actions.

The more symbols that we record and suggest to our subconsciousness will indicate that we have a strong desire to grasp and understand universal law, along with the principles of consciousness, then our subconsciousness will have the opportunity to create the conscious capacity for expanding our awareness to the remembrance and understanding of unity while in human form.
